- 5.3 Laughton Parish Council supports both applications. The scale of the proposed extension is appropriate to the size of the existing dwelling whilst preserving the historic fabric of the listed building.

 6BN. ERECTION OF A FARROWING SHED, AGRICULTURAL BARN AND ASSOCIATED BARN AND ASSOCIATED WORKS.

5.5 Comments and observations

5.6 Laughton Parish Council recommends refusal of this application.

The two storey barn is unnecessary and is exceedingly poorly located relative to its stated functional need as a fodder store for the farrowing barn.

There are fundamental concerns over the practicalities of keeping animal fodder at first floor level.

There is no requirement to keep paperwork on site and so an office is unnecessary.

The likely profit from 80 piglets a year does not justify the expenditure on the buildings.

With ancient woodland forming the majority of the site and Wealden clay the rest, the potential scale of the "farm" is naturally restricted so a successful enterprise is highly improbable.

The prevailing wind (south westerly) is going to cause issues with air borne smell to nearby dwellings on Broomham Lane i.e. the site is not suitable for a pig breeding business.

There is no provision for slurry management.

If the application is approved the Parish Council would want a condition which requires the removal of the barn and farrowing shed should agricultural production cease on the site. This is to safeguard the Low Weald landscape from creeping development into the countryside.
